Kathy Fields, former superintendent of Jessamine County Schools, will serve as the Interim CEO of CKEC from March 16, 2020 until a permanent CEO is hired. Fields will fill the position previously held by Dr. Dot Perkins. Dr. Perkins recently announced her resignation, effective March 26, 2020, in order to spend more time caring for her family.
